WHEREAS, we the said Henry C. Center and Peggy B. Center
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of
Twenty Seven Thousand and No/100 - (\$ 27,000.00) Dollars,
with interest from the date hereof at the rate of seven 1/2 per cent (7½%) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of Two Hundred Seventeen and 52/100 -

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located in the City of Greer at the intersection of Mt. Vernon Rd. and another street and being shown and designated as all of lot number TWENTY ONE (21) on plat of BURGISS HILLS, SECTION III, made by Piedmont Engineers & Architects, dated Sept. 15, 1963, which plat is recorded in R. Reginning on the Eastern side of Mt. Vernon Poad at the joint corner of Lots and 22 and running thence as the common line of said lots S. 77-06 E., 152.6 feet to Lot No..20; thence as the common line of lots 20 and 21, S. 14-00 W., 160 feet to the northern side of a street; thence with the northern side of this street, N. 74-30 W., 85 feet to angle; thence still with said road N. 58-15 W. 62 feet; thence on a curve, 37 feet, the cord of which is N. 16-20 W., to the eastern side of Mt.
