NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Northwest side of Millbrooke Circle and on the Northwest side of Millbrooke Court near the City of Greenville, and being shown as Lot 13 on Plat of Pine Knoll Forest, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book XX page 187 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the Northwest side of Millbrooke Circle at the joint front corner of Lots 12 and 13 and running thence along the line of Lot 12 N. 22-54 E. 134 feet to an iron pin; thence S. 41-0 E. 148.1 feet to an iron pin on the Northwest side of Millbrooke Court; thence along Millbrooke Court S. 49-0 W. 85.3 feet to an iron pin; thence with the curve of Millbrooke Court and Millbrooke Circle (the chord being N. 86-0 W. 35.4 feet) to an iron pin on Millbrooke Circle; thence with the curve of Millbrooke Circle (the chord being N. 41-0 W. 25 feet) to an iron pir; thence still with the curve of Millbrooke Circle (the chord being N. 56-0 W. 40 feet) to the beginning corner.
