ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 6, Sheet One, Buxton, on plat recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4N, at Page 2, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the edge of Bromsgrove Drive, joint front corner of Lots Nos. 5 and 6, and running thence with said Drive, S. 70-23 E. 75 feet to a point; thence, S. 76-12 E. 55 feet to a point at the intersection of Bromsgrove Drive and Norwich Drive; thence with said intersection, S. 27-22 E. 32.9 feet to a point on the edge of Norwich Drive; thence with said Drive, S. 21-30 W. 120 feet to a point, joint corner of Lots Nos. 6 and 7; thence with the common line of said lots, N. 69-05 W. 161 feet to a point; thence, N. 24-15 E. 133.4 feet to a point on the edge of Bromsgrove Drive, the point of beginning.
