"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Kingsridge Drive, near the City of Greenville S.C., being shown as Let No. 8 on a plat of Betany Woods Inc., recerded in the R.M.C. Office for Greenville County in Plat Book YY, page 173, and described as fellews:
