conditions), said note to be repaid with interest as the rate or rates therein specified in installments of ...... One Hundred,...

Twenty-Five and 62/100 ------(\$ 125.62) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not soone.
