WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-eight Thousand Five Hundred and No/100 DOLLARS

(\$ 28,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southerly side of Gold Springs Road, in the City of Mauldin, S. C., and being designated as Lot No. 61 on plat entitled "Section III Forrester Woods" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, page 51 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Cold Springs Road, joint front corner of Lots 61 and 62 and running thence along the common line of said lots S 16-56 E 165 feet to an iron pin; thence N 76-01 W 100 feet, more or less, to an iron pin on the easterly side of an unnamed street; thence along said street N 16-56 E 60 feet to an iron pin; thence continuing along said street N 9-34 E 116.9 feet to an iron pin at the corner of the intersection of said street and Cold Springs Road; thence along the corner of said intersection on a curve, the chord of which is N 64-30 E 28.7 feet to an iron pin on the southerly side of Cold Springs Road; thence along said Road S 60-30 E 100 feet to an iron pin, the point of beginning.
