Chastain \* , and assigns, that certain mortgage from James A. Holcombe, Sr. to The Federal Land Bank of Columbia, dated March 10, 1947 , and recorded in the public records of Greenville County, South Carolina, in Book 360 , at page 37 , and the indebtedness secured thereby which is evidenced by an amortization note of the same date, except that neither the stock issued by The Federal Land Bank of Columbia or by any national farm loan association in connection with this loan, nor any interest in said stock or proceeds thereof, is assigned.
