MORTGAGE

THIS MON'GAGE is made this 10th day of May ,19.73, between the Mortgagor, Claire O. Lopez and Patricia J. Lopez (herein "Borrower"), and the Mortgagee, Cameron-Brown Company , a corporation organized and existing under the laws of North Carolina , whose address is 4300 Six Forks Road, Raleigh, North Carolina, 27609 (herein "Lender").

Whereas, Borrower is indebted to Lender in the principal sum of Thirty-nine Thousand Nine Hundred & no/100--- Dollars, which indebtedness is evidenced by Borrower's note of even date herewith (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on June 1st,

To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of ... Greenville , State of South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Winsford Drive, being shown and designated as Lot No. 53, on a plat of SHEET NO. 1 of BUXTON, made by Piedmont Engineers and Architects, dated November 5th, 1970, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-N, at pages 2, 3 and 4, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Winsford Drive at the joint front corners of Lots Nos. 53 and 54 and running thence along the southwestern side of Winsford Drive S. 36-30 E., 120 feet to an iron pin; thence along the line of Lot No. 52, S. 53-57 W., 160 feet to an iron pin; thence N. 36-30 W., 120 feet to an iron pin at the joint rear corners of Lots Nos. 53 and 54; thence along the common line of said lots N. 53-57 E., 160 feet to an iron the beginning corner.

To Have and to Hold unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Mortgage.
