All that piece, parcel or lot of land, with the improvement thereon, situate, lyingand being in or near the City of Greenville, Greenville County, South Carolina, andbeing more particularly described as Lot No 111, Section A., as shown on a Platentitled "A" Subdivision for Woodside Mills, Greenville, S.C." made by Pickell and Pickell Engineers, Greenville, S.C. Jamuary 14, 1950, and recorded in the R.M.C. Office forGreenville County in Plat BookW, at pages 111-117, inclusive.
