

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a proiod of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and lying and being on the corner of Connecticut Drive and Parliment Road and being shown as Lot No. 15 on a plat of Merrifield Park, Section II, recorded in the RMC Office for Greenville County in Plat Book WWW at Pages 50 and 51 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Connecticut Drive at the joint front corner of Lot 14 and running thence with the line of Lot 14, S. 70-46 E. 175.75 feet; thence S. 17-04 W. 116.7 feet to an iron pin on the west side of Parliment Road; thence with the west side of Parliment Road, N. 75-55 W. 160 feet to an iron pin at the corner of Parliment Road and Connecticut Drive; thence with the said corner, N. 28-42 W. 34 feet to an iron pin on the east side of Connecticut Drive; thence with the east side of Connecticut Drive, N. 18-32 E. 71.8 feet to a point; thence still with the east side of Connecticut Drive, N. 27-16 E. 37 feet to the point of beginning.
