

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

KNOW ALL MEN That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwest side of Gate-wood Avenue, being known and designated as Lot 190, Sector 4 of a subdivision known as Poinsettia, said subdivision situate within the corporate limits of the Town of Simpsonville, and said plat of subdivision is recorded in the RMC Office for Greenville, S. C. in Plat Book 4-N, Page 24 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Gatewood Avenue at the joint corner of Lots 189 and 190 and runs thence along the line of Lot. 189 N. 47-54 W. 187.5 feet to an iron pin; thence along the line of Lot 188 S. 35-06 W. 112 feet to an iron pin; thence continuing along the line of Lot 188 S. 41-11 W. 8 feet to an iron pin; thence along the line of Lot 191 S. 47-36 E. 173.1 feet to an iron pin on the northwest side of Gatewood Avenue; thence along Gatewood Avenue N. 42-20 E. 120 feet to the beginning corner.
