All that lot or tract on Greenville Township, Greenville County, State of South Carolins, on the Northern Side of Bramlett Road, and Being a part of the property shown on plat of Property of W.A. Holliday, recorded in Plat Book F, at page #167, and being shown more particularly described, according to survey made by R.E. Dalton, November 1925, as follows.......
