NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that piece, parcel or lot of land situate, lying and being on Hyde Circle, in the Town of Mauldin, County of Greenville, State of South Carolina and being shown on the Greenville County Block Book as Sheet M3.1, Block 1, Lot 25 and according to a survey and unrecorded plat by W. J. Riddle dated December 4, 1950 has the following metes and bounds, to-wit:

BEGINNING at a point in the center of Hyde Circle, joint corner of lot now or formerly of W. A. Wilson and running thence S. 24-45 E., 209.5 feet to a stake; corner of lot now owned by W. A. Wilson; thence along the Wilson line S. 75-15 W., 104.8 feet to a stake on Fowler line; thence with Fowler line, N. 24-45 W., 209.5 feet to a point in the center of said Hyde Circle; running thence along said road, N. 75-15 E., 104.8 feet to the point of beginning.
