SEND GREETING:

WHEREAS, we the said Kenneth L. Wolfe and Frances S. Wolfe
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of
Three Thousand Five Hundred and no/100 - - - (\$3,500.00) Dollars,
with interest from the date hereof at the rate of eight per cent (8%) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

Wolfe , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Citizens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor.s. in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the south side of Roscoe Drive, about one mile southward from the City of Greer, and being Lot #5 in Brookhaven, property of the Dobson Estates, according to survey and plat by H. S. Brockman, Registered Surveyor, dated December 12, 1957, amended September 1, 1959, recorded in Plat Book RR, Page 41, R. M. C. Office for Greenville County, and having the following courses and distances, to wit:

BEGINNING at an iron pin in the center of Roscoe Drive, corner of Lots Nos. 4 and 5, and running thence along the line of said lots, S. 10-55 W., 170 feet to an iron pin, rear corner of Lot #25; thence along the line of Lot #25, S. 79-25 E., 100 feet to an iron pin, corner of Lot #6; thence along the line of Lot #6, N. 10-55 E., 170 feet to the center of Roscoe Drive; thence along said Drive, N. 79-25 W., 100 feet to the beginning corner.
