NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, consisting of 33.1 acres, more or less, and being more particularly described by a Plat prepared by J. Q. Bruce, dated August 27, 1965, and recorded in the RMC Office of the Greenville County Courthouse in Plat Book GGG at Page 297 as follows:

BEGINNING at an iron pin at the center of a County road and running thence along property now or formerly belonging to Malcolm D. Gibson, S. 17-43 W. 1,927.5 feet to an iron pin; thence S. 66-37 W. 603 feet to an old stone; thence along property now or formerly owned by Barton N. 25-37 W. 1,963 feet to the center of said County road; thence along the center of said road N. 64-00 E. 278.5 feet; thence still with the center of said road N. 71-23 E. 612.2 feet to the point of beginning.
