NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3,00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, burgained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of lind, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, containing one-half acre, more or less, and having the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of the intersection of Parker Road with Patrol Club Road, and running thence along the center of Patrol Club Road, N. 36-30 E. 100.9 feet to a nail and cap in said road at the corner of a triangular parcel conveyed by the mortgagor to Eugene H. Manley as aforementioned; and the second, a deed to mefrom the said Eugene H. Manley dated July 24, 1958 and recorded in the R. M. C. Office in Deed Vol. 602, at page 531.
