NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, at the Southwestern corner of the intersection of Greybridge Drive and Rivendell Drive, being known and designated as Lot No. 138 as shown on a plat entitled "Trollingwood Section 2", prepared by Enwright Associates, Engineers, dated May 11, 1973, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X, Page 46, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Rivendell Drive at the joint front corner of Lots Nos. 137 and 138 and running thence with the line of Lot No. 137 S. 33-22 W. 201.1 feet to an iron pin; thence N. 56-39 W. 168 feet to an iron pin; thence N. 30-23 W. 71.8 feet to an iron pin on the Southern side of Greybridge Drive; thence with the Southern side of Greybridge Drive N. 51-21 E. 52 feet to an iron pin; thence continuing with the Southern side of Greybridge Drive N. 44-53 E. 97.2 feet to an iron pin; thence with the intersection of Greybridge Drive and Rivendell Drive N. 84-05 E. 38.74 feet to an iron pin; thence with the Southwestern side of Rivendell Drive S. 56-43 E. 166.1 feet to the point of beginning.
