

And if any portion of principal or interest be at any time past dee and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an atturney for suit or collection, or if before its materity, it should be deemed by the holder

thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including (10%) per cent, of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate, lying and being on the southeastern side of Dundee Lane in Paris Mountain Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 22 of a subdivision known as Stratford Forest, and having according to a plat of said sub-

division prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 89, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Dumdee Lane at the joint front corner of Lots Nos. 21 and 22 and running thence with the line of Lot No. 21 N. 82-25 E. 321.7 feet to an iron pin; thence S. 32-39 W. 409.9 feet to an iron pin at the joint rear corner of Lots Nos. 22 and 23; thence with the line of Lot No. 23 N. 57-41 W. 186 feet to an iron pin on the southeastern side of Dundee Lane; thence with the curve of the southeastern side of Dundee Lane, the chord of which is N. 22-52 E. 112.4 feet to an iron pin; thence continuing with the curve of the southeastern side of Dundee Lane, the chord of which is N. 6-59 E. 101.0 feet to the point of beginning.
