(6) To use the loan evidenced by the note solely for purposes authorized by the Government.

(7) To pay when doe all taxes, fiens, judgments, encumbrances and assessments lawfully attaching to or assessed against the property and promptly deliver to the Government without demand receipts evidencing such payments.

(8) To keep the property insured as required by and under insurance policies approved by, delivered to, and retained by the Government. (9) To maintain improvements in good repair and make repairs required by the Government; operate the property in a good and husband-manlike manner; comply with such farm conservation practices and farm and home management plans as the Government from time to time may prescribe; and not to abandon the property, or cause or permit waste, lessening or impairment of the security covered hereby, or, without the written consent of the Government, cut, remove, or lease any timber, gravel, oil, gas, coal, or other minerals except as may be necessary for ordinary dozestic purposes.

(10) To comply with all laws, ordinances, and regulations affecting the property.

(11) To pay or reimborse the Government for expenses reasonably necessary or incidental to the protection of the lieu and priority hereof and to the enforcement of or the compliance with the provisions hereof and of the note and any supplementary agreement (whether before or after default), including but not limited to costs of evidence of title to any survey of the property, costs of recording this and other instruments, attorneys' fees, trustees' fees, court costs, and expenses of advertising, selling, and conveying the property.

(12) Neither the property nor any portion thereof or interest therein shall be leased, assigned, noid, transferred, or encumbered, voluntarily or otherwise, without the written consent of the Government. The Government shall have the sole and exclusive rights as mortgagee beremoder, including but not limited to the power to grant consents, partial releases, subordinations, and satisfaction, and so insured holder shall have any right, title or interest in or to the lieu or any benefits hereof.

(13) At all reasonable times the Government and its agents may inspect the property to ascertain whether the covenages and agreements contained herein or in may supplementary agreement are being performed.

(14) The Government may extend and defer the materity of and renew and remounting the debt evidenced by the note or any indebtedness to the Government secured hereby, release from linbility to the Government any party so liable thereon, release portions of the property from and subordinate the lien bereof, and waive any other rights hereander, without affecting the lien or priority hereof or the liability to the Government of Borrower or any other party for payment of the note or indebtedness necessed hereby except an openified by the Government in writing.

(17) SHOULD DEFAULT occur in the performance or discharge of any obligation secured by this instrument, or should any one of the parties named as Borrower die or be declared an incompetent, a bankrupt, or an insolvent, or make an assignment for the benefit of creditors, the Government at its option, with or without notice, may: (a) declare the entire amount uspaid under the note and any included to the Government at its option, with or without notice, may: (a) declare the entire amount uspaid under the note and any included the Government kereby secared incrediately dec and payable, (b) declare the account of Borrower and pay reasonable expenses for repair or maintenance of and take possession of, operate or rent the property, (c) upon application by it and production of this instrument, without notice of heuring of said application, have a receiver appointed for the property, with the usual powers of receivers in like cases, (d) foreclose this instrument as provided herein or by few, and (e) enforce any and all other rights and remedies provided herein or by present
