Section 8.7. Liability of Trustees. No trustee hereunder shall be personally liable by reason of any act or omission of any other trustee hereunder.

Section 8.8. Segregation of Moneys. All moneys received by the Trustees pursuant to this Indenture shall be held in trust for the purposes for which they were paid, but, except as otherwise provided herein and to the extent required by law, need not be segregated from any other moneys, and may be deposited by the Trustees under such general conditions as may be prescribed by law in the general banking department of the Trustee, and the Trustee shall not be liable for any interest thereon.

Indenture or any amendment or supplement hereto shall be deemed to impose any duty or obligation on the Trustee to perform any act in the execution of the trust or to exercise any right, power, duty or obligation conferred or imposed on it, which under any present or future law shall be unlawful, or which shall be beyond the corporate powers, authorization or qualification of the Trustee, but any such act and any such exercise shall be performed and exercised by the Individual Trustee or by any separate trustee or co-trustee appointed as provided in Section 8.6, provided, that the same shall not be unlawful or beyond his or its powers, authorization or qualifications:
