



Murray, Donald R. Waugh, Jr., Howard E. Thomas, Charles F. Adams, Frank H. Briggs, Trammell Crow, J. Frank Forster, Grant Keehn, Thomas M. Nacioce, Robert C. Tyson, and John C. Whitehead, as Trustees of a Massachusetts business trust under a Declaration of Trust, dated September 15, 1970, as amended, having an office at 75 Federal Street, Boston, Massachusetts, and designated in said Trust as THE EQUITABLE LIFE MORTGAGE AND REALTY INVESTORS, or order, as their interests may appear, that certain Mortgage executed by Redman Development Corporation to the said Trustees of American Century Mortgage Investors in the principal amount of Two Million One Hundred Thousand (\$2,100,000.00) Dollars, dated July 17, 1971, and recorded in the R.H.C. Office for Greenville County, South Carolina, in Mortgage Book 1200, at page 353.

This assignment and every undertaking made pursuant hereto is executed in behalf of American Century Mortgage Investors by one or more Trustees, officers or agents of the Trust in his or their capacity as such and not individually, under a Declaration of Trust dated May 14, 1969, a copy of which, together with all amendments thereto (the "declaration") is on file in the office of the Secretary of the Commonwealth of Massachusetts; and the obligations thereof shall be understood and expressly stated not to be binding upon any of the Trustees, shareholders, officers or agents of the Trust, personally, but binding only upon the trust estate of American Century Mortgage Investors.
