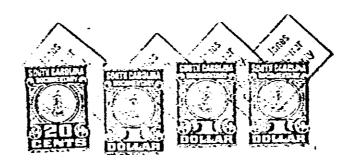

M. C. Office for Greenville County in Plat Book BBB at Page #57 and being more particularly described in accordance with said plat, towit:

BEGINNING at a point in the edge of Belmont Drive, joint front corner of Lots 10 and 11, and running thence along joint line of Lots 10 and 11 N. 27-20 E. 261.7 feet to a point, joint rear corner of Lots 10 and 11; thence N. 60-28 W. 150 feet, more or less, to a point; thence S. 27-20 W. 267, more or less, said line running down the center of Lot 12 to a point in the edge of Belmont Drive; thence along the edge of Belmont Drive S. 62-28 E. 150 feet, mor or less, to the point of beginning.
