MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Rodney Nelson and Beth W. Nelson

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Thirty Four

Thousand One Hundred Fifty and No/100----- (\$ 34,150.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note contains a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred

Fifty and 59/100----- (\$ 250.59) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

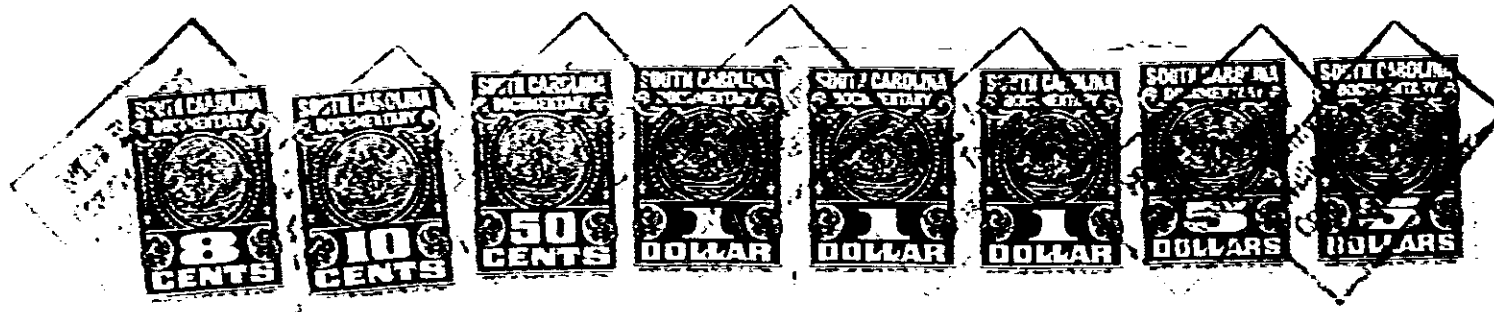
WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, State of South Carolina being on the northeastern side of Pheasant Trail, being known and designated as Lot # 4, as shown on a plat entitled "Final Section I, Forrester Woods" dated March 14, 1972, prepared by R. B. Bruce, registered surveyor, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4N at Page 78 and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 3 and 4, thence with the line of Lot No. 3 N27-17 E 150 feet to an iron pin in the line of property now or formerly of E. D. Kellett, joint rear corner of Lots Nos. 3 and 4; thence with the line of property now or formerly of E. D. Kellett N 62-43 W 110 feet to an iron pin joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 S 27-17 W 150 feet to an iron pin in the right of way for Pheasant Trail, joint front corner of Lots Nos. 4 and 5; thence with the rights of way for Pheasant Trail S 62-43 E 110 feet to the point of beginning.
