To All Whom These Presents May Concern:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (bereinafter referred to as Mortgagee) in the full and just sum of

WHERE'S said note further asserted that if at any time any mation of the principal or interest due thereunder shall be reset

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Tamarack

Trail, being shown as Lot No. 20 on plat of Fontana Forest as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book YY, at Page 171, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the northern side of Tamarack Trail, joint front corner of Lots Nos. 20 and 21, and running thence with said Trail, S. 72-23W. 100 feet to a point, joint front corner of Lots Nos. 20 and 19; thence with the common line of said lots, N. 17-37 W. 175 feet to a point; thence, N. 72-23 E. 100 feet to a point, joint rear corner of Lots Nos. 20 and 21; thence with the common line of said lots, S. 17-37 E. 175 feet to a point on the northern side of Tamarack Trail, the point of beginning.
