"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northerly side of Berea Lane, being shown and designated as Lot 6 on a plat of property of J. E. Williams recorded in the R. M. C. Office for Greenville County in Plat Book HH at Page 141, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Berea Lane at the joint front corner of lots 6 and 7 and running thence along said Berea Lane, N. 84-31 W., 100 feet to an iron pin; thence along the joint line of Lots 5 and 6, N. 5-29 E., 167.8 feet to an iron pin; thence S. 84-15 E., 100 feet to an iron pin; thence S. 5-29 W., 167.4 feet to an iron pin on Berea Lane, point of beginning.
