All that piece, parcel or lot of land, with the buildings and improvements thereon, Situate, lying and being in the City of Greenville, in the County of Greenville, State of South Carolina, and being known as a portion of Lot 7 on plat of Oakland Heights which plat is recorded in the RMC Office for Greenville County, S. C., in Plat Book C at page 147 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the Southeastern intersection of Webster Street and Oakland Avenue; and running thence S. 34-50 W. 40 feet to a point thence through Lot 7, S. 64-34 E. 65 feet to a point; thence N. 34-50 E. 40 feet to a point on Webster Street; thence along the Southern side of Webster Street N. 66-49 W. 65 feet to the point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. 
