(1) That this mostgage shall secure the Mortgagee for such further sums as may be advanced taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the coverants. further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thu; secured does not exceed the original amount shown on the face hereof.
