All that lot of land lying and being on the Southeast side of Webster Road, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 7 on a Plat of the property of E. Godfrey Webster, recorded in Plat Book U, at Page 79, and being more particularly shown on a Plat of the Property of Jack Dale prepared by J.C.
