"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being on the southern side of Crabapple Drive (now known as Cunningham Circle), near the City of Greenville, being shown and designated as Lot No. 25 on a plat of Cunningham Acres, Section No. 3, made by C. O. Riddle, Surveyor dated April 8, 1971, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4-N, page 73 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Crabapple Drive (Cumningham Circle) at the joint front corner of Lots Nos. 24 and 25 and running thence along the common line of said lots, S. 3-10 E. 165.08 feet to an iron pin on the line of Lot No. 13; thence along the line of said lot, S. 86-50 W. 64.1 feet to an iron pin at the joint rear corners of Lots Nos. 25 and 26; thence along the common line of said lots, N. 23-02 W. 149.2 feet to an iron pin on Crabapple Drive (Cunningham Circle); thence along the southern side of said Drive, N. 69-11 E. 59 feet to an iron pin; thence continuing along the southern side of said Drive, N. 80-11 E. 59 feet to an iron pin, the beginning corner.
