

Ducker. his heirs and assigns, forever:

ALL those lots of land, on the North side of Edwards Road, near the City of Greenville, in Greenville County, South Carolina, being shown as part of Lot 27 and all of Lots 28 and 29, on plat of Green Hills, made by Piedmont Engineers Services, October, 1954, recorded in the R. M. C. Office for Greenville County, in Plat Book "HH", at Page 189, and having, according to said plat, when described together, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Edwards Road, at the joint front corner of Lots 29 and 30, and runs thence along the line of Lot 30, N. 20-35 W., 208.2 feet to an iron pin; thence N. 81-05 E., 141 feet to an iron pin at the rear corner of Lots 27 and 28; thence on a new line through Lot 27, N. 75-20 E., 78.9 feet to an iron pin in the joint line of Lots 26 and 27; thence along Lot 26, S. 40-47 E., 126.8 feet to an iron pin on the North side of Edwards Road; thence along Edwards Road, S. 51-09 W., 97 feet to an iron pin; thence continuing with Edwards Road, S. 57-31 W., 185 feet; thence continuing with Edwards Road, S. 66-15 W., 85 feet to the beginning corner.
