per centum per annum, to be paid: monthly



NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina. County of Greenville, City of Greenville, and being known and designated as Lot No. 10 of North Park Addition, according to a Plat by Dalton & Neves, dated April, 1941, and recorded in the RMC Office for Greenville County in Plat Book K at Page 89 and being more particularly described as follows:

BEGINNING at a stake on the south side of Gallivan Avenue, corner of Lot No. 9, and running thence with said Lot, S. 24-30 W. 178 feet to a stake in a branch; thence down and with the meanderings of said branch, 88.2 feet, more or less, to a stake; thence N. 13 E. 166 feet to a stake on said avenue; thence with said avenue, N. 65-30 W. 55 feet to the beginning.

It is understood and agreed that this mortgage constitutes a second and junior lien to that certain mortgage held by Fidelity Federal Savings & Loan Association dated April 10, 1959 and recorded in the RMC Office for Greenville County in Mortgage Book 782 at Page 365.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that is is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
