FOR VALUE RECEIVED, AIKEN-SPEIR, INCORPORATED, A South Carolina corporation with a home office in Florence, South Carolina, does hereby assign, setover and transfer unto WESTERN AND SOUTHERN LIFE INSURANCE COMPANY of Cincinnati, Ohio, Its successors and assigns, all its right, title and interest in and to that certain mortgage loan given by Martin-Wright Associates, a South Carolina general partnership to Bankers Trust of South Carolina, N.A. on October 18, 1973 in the amount of \$665,000.00 covering property known as 4.05 acres situate, lying and being on the western side of Laurens Road in the City of Greenville, Greenville County, South Carolina as shown on a plat thereof recorded in the RMC Office for said County and State in Plat Book 5-B, page 31, assigned by Bankers Trust of South Carolina, N.A. to Aiken-Speir, Incorporated April 15, 1974, recorded in the RMC Office for Greenville County, S.C. That certain open-end mortgage given by Martin-Wright Associates to Bankers Trust of South Carolina, N.A. in the sum of \$665,000.00 covering the above described 4.05 acres dated October 18, 1973 and recorded in the RMC Office for Greenville County, S.C. on October 18, 1973 at 4:28 o'clock P.M. in Mortgage Book 1293, page 317, as amended by a First Amendment dated March 29, 1974 between Martin-Wright Associates and Bankers Trust of South Carolina recorded April 15, 1974 at 4:33 o'clock P.M. in the RMC Office for Greenville County, S.C. in Mortgage Book 1307, page 249.

3. Collateral Assignment of Lease given by Martin-Wright Associates a general partnership to Bankers Trust of South Carolina, N.A. covering a lease executed by Martin-Wright Associates to J. P. Stevens & Co., Inc., a Delaware corporation for a term of twenty (20) years with two successive ten year options to renew dated August 6, 1973, as amended by a First Amendment dated February 28, 1974, a memorandum of agreement of lease of which is dated August 6, 1973, recorded in the RMC Office for Greenville County, S.C. on October 18, 1973 at 4:27 o'clock P.M. in Deed Book 986, page 353.

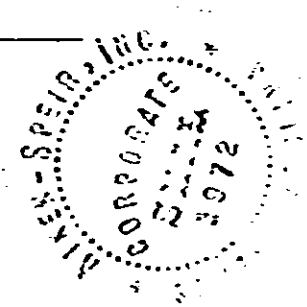
