"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in or near the City of Greenville, on the northern side of Holgate Drive, being shown as Lot No. 156 on plat of Section III, Wade Hampton Gardens, recorded in the R.M.C. Office for Greenville County in Plat Book "YY", page 179, and described as follows:

BEGINNING at an iron pin on the northern side of Holgate Drive at the corner of Lot No. 157 and running thence with the northern side of said Drive S. 74-33 W. 110 feet to an iron pin on the corner of Lot No. 155; thence with the line of said lot N. 15-27 W. 170 feet to an iron pin in the line of Lot No. 150; thence with the line of Lots Nos. 150 and 149 N. 74-33 E. 110 feet to an iron pin at the corner of Lot No. 57; thence with the line of said lot S. 15-27 E. 170 feet to the beginning corner.
