NOW, KNOW ALL MEN, that I the said Elsie Nash
in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which
with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and
truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowled-
ged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said
Domestic Loans of Greenville, Inc.

All that lot of land with the buildings and improvements thereon, situate on the
West side of McCall Street in the City of Greenville in Greenville County, South
Carolina, and having, according to a survey made by R. H. Campbell on February 20,
1962, the following notes and boundaries, to-wit:

Beginning at an iron pin on the West side of McCall Street, said pin being 490.5
feet North from the Northwest corner of the intersection of McCall Street and
Shett Street and runs the same N. 71-47 W. 101 feet to an iron pin; thence N. 10-49 W.
52 feet to an iron pin; thence N. 71-47 E. 101 feet to an iron pin on the West
side of McCall Street; thence along McCall Street, S. 10-49 E., 52 feet to the
beginning corner.

This is the same property conveyed to Marie E. Stone by deed of L. E. Cimberis
dated October 1, 1961, recorded in the Office of the Greenville County, S. C.
in Deed Book 448, Page 60. Subsequently, Marie E. Stone died testate and by her
will which is on file in the Probate Court for Greenville County, S. C. in Apt
607, File 13, she devised a life estate in said property to the daughter H. C. Stone
and the remainder to the daughter Earle C. Stone.

This conveyance is subject to all restrictions, set back lines, roadways, easements
and rights of way, if any, affecting the above described property.
