We, Beattie M. Wade and Scottie Wade

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Twenty-Eight Thousand Five Hundred-----DOLLARS**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and lying on the Northwest side of Manly Drive, in Paris Mountain Township, shown and designated as Lot #6 on a plat of Paris Mountain Heights, recorded in the office of the R.M.C. for Greenville County in Plat Book HH at page 151; Being the identical premises heretofore conveyed to the mortgagors by deed of Julian Ray Pate and Julia Ann Pate of even date recorded in Deed Book 1041 at page 142. Beginning at an iron pin at the joint front corner of Lots 5 and 6 on the Northwest Side of Manly Drive and running thence with the common line of Lots 5 and 6 N. 43-20 W. 209.5 feet to an iron pin on Manly Drive, thence with Manly Drive N. 56 E. 87.6 feet to an iron pin joint corner of Lots 6 & 7 thence S. 47E. 207.8 Feet to iron pin, thence with Manly Dr. S. 53 E. 100 feet to point of beginning.
