

The Paying Agent shall furnish the Trustee with regular monthly or semi-annual reports of the deposits made by the Issuer in the Interest and Bond Payment Account and shall forward all bonds to the Trustee as they mature and are presented for payment.

The Paying Agent shall not be required to give any bond or security in respect to the performance of its duties and obligations hereunder.

The Paying Agent may at any time resign from the duties and obligations imposed upon it hereunder by giving thirty (30) days' notice in writing to the Issuer. Such notice shall be delivered personally or by registered mail. Such resignation shall take effect at the end of such thirty (30) days or upon the earlier appointment of a successor Paying Agent. Every successor Paying Agent appointed hereunder shall execute, acknowledge and deliver to its predecessor and to the Issuer an instrument in writing accepting such appointment hereunder and shall thereupon become fully vested with and responsible for all of the duties and obligations as Paying Agent hereunder. The Paying Agent agrees, however, that if, after its resignation hereunder, any bonds of this bond issue are presented to it for payment that it will return the same, with a letter advising the name and address of the successor Paying Agent, to the bond holder.

The Paying Agent for this bond issue shall be responsible only for the performance of the duties and obligations specifically imposed upon it under the provisions of this Section and Section XI hereof and for its own negligence or willful default in the performance of such duties and obligations.

SECTION VIII.

That in the event a successor Paying Agent is appointed by the Issuer hereunder in accordance with the provisions of
