WHEREAS, I the said Joe M. Forrester

bear interest at the same rate, to be repaid in installments of One Hundred Forty Seven and 72/100



Forrester, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Citizens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and teleased, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, on the west side of the Rutherford Road, at Oneal, and being Lot No. 1 of the S. M. Forrester property according to survey and plat by H. S. Brockman, Surveyor, dated April 13, 1959, and having the following courses and distances, to wit:

BEGINNING at a point in a dirt road that leads from the Rutherford Road to Highway 101, joint corner of the Beacham and Few property, and runs thence with the road, N. 89-45 E., 100 feet to a bend; thence N. 76-25 E., 100 feet to a bend; thence N. 69-27 E., 69.8 feet to a nail and cap in the center of the Rutherford Road; thence with the Rutherford Road, N. 14-45 E., 100 feet to a nail and cap in the center of the said road; joint corner of Lots Nos. 1, and 2; thence with the common line of Lots Nos. 1 and 2, N. 76-45 W., 25 feet to an iron pin on the bank of the road; thence continuing with the same course for a total distance of 241.3 feet to an iron pin on the Willimon line; thence with the said line, S. 14-55 W., 208 feet to the beginning corner.
