WHEREAS: We, James J. Satterfield and Sara F. Satterfield

of Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

North Carolina National Bank Charlotte, N.C., a corporation organized and existing under the laws of the United States, whose address is/ hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of - - Twenty-eight thousand nine hundred fifty - - - - - Dollars (\$ 28,950.00), with interest from date at the rate of Eight per centum (8 %) per annum until paid, said principal and interest being payable at the office of NCNB Mortgage South, Inc., P. O. Box 10068 in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of - Two hundred twelve and 49/100 - - - - - Dollars (\$ 212.49), commencing on the first day of February, 19 77, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 2007 .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; on the eastern side of Keller Road, being shown and designated as Lot 3 on a Plat of Boyd C. Lister Property, recorded in the RMC Office for Greenville County in Plat Book 3-R, at Page 173. Said Lot fronts 120.0 feet on the eastern side of Keller Road; runs back a uniform depth of 180.0 feet, and is 120.0 feet across the rear.

This is the same property conveyed to the mortgagors herein by deed of Edward Ervin Tadlock and Martha Jane T. Tadlock, dated December 17, 1976, to be recorded simultaneously herewith.
