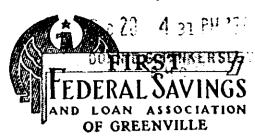

Fifty Four and 02/100 (\$ 354.02) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due there under shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose:

NOW KNOW ALL MEN. That the Mortzagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortzagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortzagor in hand well and truly paid by the Mortzagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot 178, Sugar Creek Subdivision, Section One and having, according to a plat prepared by C.O. Riddle, surveyor, recorded in the Office of the R.M.C. for Greenville County, South Carolina in Plat Book 4R at Page 85, the following metes and bounds:

BEGINNING at a point on the southwestern side of Stone Ridge Road at the joint front corner of Lots 178 and 179, and running with the line of Lot 179, S. 61-17-15 W. 119.64 feet to the joint rear corner of Lots 177 and 178; thence with the line of Lot 177, N. 32-18-13 W. 137.51 feet to a point on the Southeastern side of White Water Court; thence turning and running along White Water Court N. 57-41-47 E. 102.53 feet; thence turning and running S. 76-31-51 E. 34.89 feet to a point on Stone Ridge Road; thence turning and running along said road S. 28-44-54 E. 120.23 feet to the point of beginning.
