WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated

herein by reference, in the sum of TEN THOUSAND FIVE HUNDRED and no/100

DOLLARS (\$ 10,500.00 ), with interest thereon from date at the rate of nine per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, in **Chick**

**Springs Township**, containing approximately one and one-half acres, and having the following metes and bounds, to-wit:

Beginning at an iron pin at the corner of John S. Loftis on the southern side of S.C. Highway 253, and running thence along Loftis S 37-40 W 573 feet to an iron pin; thence N 41-15 W 150 feet to an iron pin; thence N 39-20 E 431.5 feet to an iron pin on the sothern side of S.C.
