Melville D. Ramsey and Doris A. Ramsey
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of
Forty-Six Thousand Eight Hundred Fifty and No/100----- DOLLARS

(\$ 46,850.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

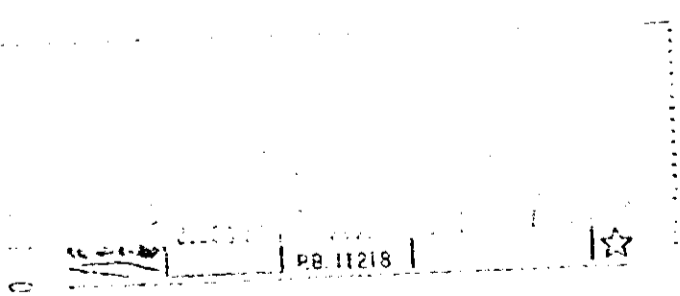
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of White Water Court, being known and designated as Lot No. 166 as shown on a plat of Sugar Creek, Map 2, Section I, prepared by C. O. Riddle, dated June 14, 1974, recorded in the RMC Office for Greenville County in Plat Book 4R at Page 85, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of White Water Court at the joint front corner of Lots 165 and 166, and running thence along the joint line of said two lots, N. 33°56'24" W. 147.33 feet to an iron pin; thence S. 56°36'54" W. 89.32 feet to the joint rear corner of Lots 166 and 167; thence with the joint line of said two lots, S. 28°31'02" E. 142.49 feet to an iron pin on the Northern side of White Water Court; thence with the Northern side of White Water Court, N. 59°35'22" E. 102.98 feet to the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Cothran & Darby Builders of even date to be recorded herewith.
