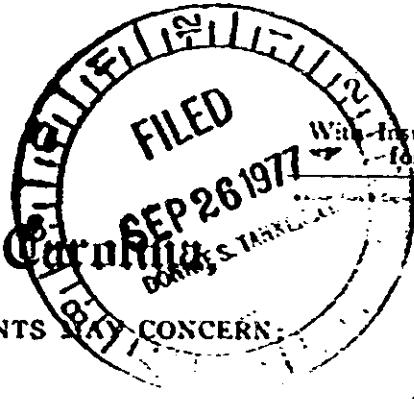

NOW, KNOW ALL MEN, that we the said Willie Lee Henderson and Ernestine Henderson in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagor in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Domestic Loans of Greenville, Inc.

All that piece, parcel or lot of land in Bitler Township, Greenville County, State of South Carolina, being designated as Tract No. 1, on a plat of a portion of the property of Lee Henderson made by J. Mac Richardson, Surveyor, dated June, 1956, and being more particularly described as follows:

Beginning at an iron pin being the joint front corner of Tract No. 1 and the property of Ed Moseley, and running thence S. 28-15 E. 620 feet to an iron pin on the line of the Robert McDaniel property; thence N. 27-30 E. 85 feet to an iron pin; thence N. 28-00 W. 627 feet to an iron pin on an ungraded County Road; thence S. 61-30 W. 67 feet to the point of beginning, said measurements extending beyond iron pin to the center of the ungraded County Road being the Northern boundary and containing one acre, more or less.

This is the same property conveyed to the Grantor herein by E. Iwan, Master, by deed dated July 15, 1959.
