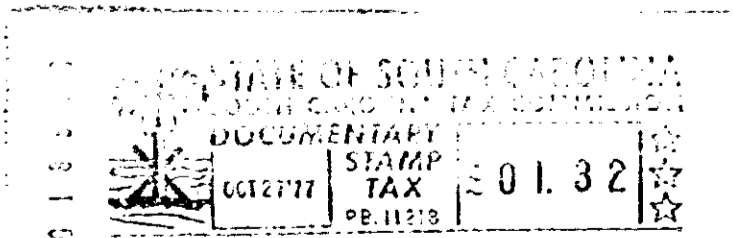
hereinafter called the mortgagee(s), in the full and just sum of Three Thousand
