DEBORAH B. PATTERSON

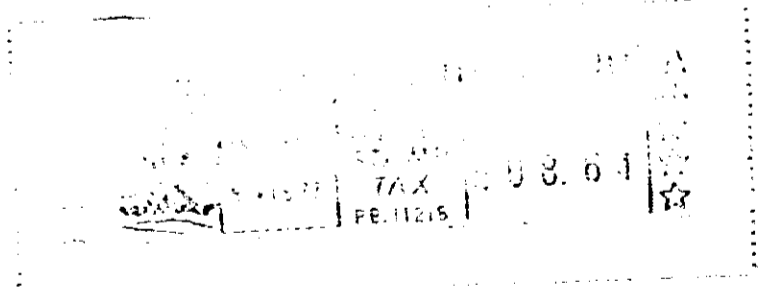
