(hereinafter also styled the mortgagee) in the penal sum of Thirteen Thousand Two Hundred and no/100
(13,200.00) Dollars.

conditioned for the payment in lawful money of the United States of America of the full and just sum of
Thirteen Thousand Two Hundred and no/100 (\$13,200.00)

as in and by the said Note and conditions thereof, reference thereto had will more fully appear

NOW, KNOW ALL MEN, that we the said William D. Larke and Gladys B. Larke in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the said Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the said mortgagee in hand well and truly paid, by the said mortgagee, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Domestic Loans of Greenville, Inc.

All that piece, parcel, or lot of land in O'Neal Township, Greenville County, South Carolina, with buildings thereon, located on the south side of McElhenny Road about one mile east of Double Springs Church and contains three acres more or less, and having the following metes and bounds, to wit:

Beginning at a point in the center of McElhenny Road at its intersection with a county road that leads to Center Ridge and running thence with Toy Powell's property line S. 5-30 E. 192.7 feet to an iron pin near a stone; thence S. 22-20 W. 26 feet over an iron pin to the center of Clear Creek; thence up the meanders of Clear Creek, the traverse line of said creek being N. 59-15 E. 505 feet to an iron pin, corner of Carl Raymond Larke lot; thence N 6-15 E. 448 feet to an point in the center of McElhenny Road thence S. 88-19 E. 534.8 feet to the beginning corner.

This is the same lot of land conveyed to the Grantor herein by Julius T. Dill, which deed is recorded in the R.M.C. Office for Greenville County, South Carolina in Deed Book 686, at page 288, and dated November 16th 1961.
