All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Quaker Court and being known and designated as Lot No. 68 on a plat of HILLSBOROUGH Subdivision, Section 11, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-F at Page 51 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Quaker Court, joint front corner of Lots 67 and 68 and running thence S.77-40 W. 131.1 feet; thence N.12-27 W. 120 feet to an iron pin; thence N.84-19 E. 111.2 feet to a point on the western side of Quaker Court; thence with said Court, as follows: S.49-43 E. 40 feet; thence S.09-52 W. 75.3 feet to the point of beginning.
