NOT KNOR ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the
payment thereof to the Mortgagee, and also in consideration of the further sum of **Three Dollars (\$3)** to the Mort-
gagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the
receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does
grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real
estate situated in the County of **Greenville**
State of South Carolina on the east side of **D Street**, being shown and designated
as **lot 40 on a Plat of JUDSON MILLS VILLAGE, Section 6**, recorded in the
RMC Office for Greenville County in Plat Book **K**, at Pages **106 and 107**.
Said lot fronts **70.0 feet** on the east side of **D Street**; runs back to a
uniform depth of **78.0 feet**, and is **70.0 feet** across the rear.

This is the same property conveyed to the Mortgagors herein by deed of
Elise G. Garrett, dated **December 21, 1977**, to be recorded simultaneously
herewith.

"The mortgagor covenants and agree so long as this mortgage and the said

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple ab-
solute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises
are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and for-
ever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all per-
sons whomsoever lawfully claiming the same or any part thereof

The Mortgagor covenants and agrees as follows:

1 That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at
the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal
to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior
to maturity, provided, however, that written notice of an intention to exercise such privilege is given at least thirty
(30) days prior to prepayment.
