### MORTGAGE (Construction—Permanent)

THIS MORTGAGE is made this 4th day of January, 1978, between the Mortgagor, R. L. Rucker Builder, Inc.

, (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 1500 Hampton Street, Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Fifty-One Thousand Six Hundred and No/100ths Dollars or so much thereof as may be advanced, which indebtedness is evidenced by Borrower's note dated January 4, 1977, (herein "Note"), providing for monthly installments of interest before the amortization commencement date and for monthly installments of principal and interest thereafter, with the balance of the indebtedness, if not sooner paid, due and payable on June 1, 2007;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage and the performance of the covenants and agreements of Borrower herein contained, (b) the performance of the covenants and agreements of Borrower contained in a Construction Loan Agreement between Lender and Borrower dated January 4, 1978, (herein "Loan Agreement") as provided in paragraph 24 hereof, and (c) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin being known and designated as Lot No. 8 on a plat of Forrester Woods, Section 7 recorded in the RMC Office for Greenville County, South Carolina in Plat Book 5P at pages 21 and 22 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the easterly side of Oakwood Court at the joint front corner of Lots 7 and 8 and running thence with the common line of said lots, S. 53-42 E. 155 feet to a point; thence S. 36-18 W. 100 feet to a point; thence N. 53-42 W. 155 feet with the common line of Lots 8 and 9 to a point on the easterly side of Oakwood Court; thence with the easterly side of said Oakwood Court, N. 36-18 E. 100 feet to the point of beginning and being the same property conveyed to the mortgagor herein by deed of W. D. Yarborough dated January 4, 1978 recorded in the RMC Office for Greenville County herewith.
