TO ALL WHOM THESE PRESENTS MAY CONCERN: ROBERT C. McMANUS AND JUDITH R.

McMANUS (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eighty Thousand and No/100----- DOLLARS

(\$ 80,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land situate, lying and being on the Northeastern side of Huntington Road, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as the greater portion of Lot No. 30A as shown on a plat of Sheet No. 1 of Huntington Subdivision, prepared by Piedmont Engineers & Architects, dated May 4, 1968, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book WW at page 23 and having, according to a more recent plat entitled "Revision of Lot No. 30A, Huntington Subdivision", dated June 20, 1977, prepared by Piedmont Engineers, Architects and Planners, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 6-F at page 69, the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Huntington Road at the joint front corner of Lots Nos. 30 and 30A and running thence with the line of Lot No. 30 N. 72-21 E. 278.4 feet to an iron pin in the line of Lot No. 29; thence with the line of Lot No. 29 S. 10-37 E. 209.4 feet to an iron pin; thence a new line through the original Lot No. 30 and with the line of Lot No. 26 as shown on the last plat referred to hereinabove S. 72-01 W. 164.72 feet to an iron pin on the Northeastern side of Huntington Road; thence with the Northeastern side of Huntington Road N. 41-41 W. 165.1 feet to an iron pin; thence continuing with the Northeastern side of Huntington Road N. 36-23 W. 61.7 feet to the point of beginning.

This is the identical property conveyed to the Mortgagors herein by deed of Nancy J. Stewart, dated July 7, 1977, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 1060 at page 147 on July 8, 1977.
