WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of East Earle Street, and having, according to plat recorded in the RMC Office for Greenville County in Plat Book C at Page 141, the following metes and bounds, to wit:

BEGINNING at a point on East Earle Street 330 ft. 10 in. from the eastern line of Main Street and running thence S 19-39 W 206 ft. 6 in. to a point; thence S 71-20 E 63 ft. to a point; thence N 19-39 E 206 ft. 6 in. to a point on Earle Street; thence along Earle Street N 71-20 W 63 ft. to the point of beginning.
